

# 2012 POOL SCHEDULE

The pool is strictly for the use of Bethany Meadows Recreation Association Members, Their Family, Guests and Tenants.

**Dates: Memorial Day Weekend through Labor Day: (Weather Permitting)**

**Daily Hours: 11:00 am to 7:45 pm. All persons must be out of the pool by 7:45 pm. (Gate is locked promptly at 8:00)**

**NO UNIT/LOT OWNER OR THEIR TENANT WILL BE ALLOWED TO USE POOL IF ALL OF THEIR FEES ARE NOT CURRENT**

The pool will be closed during inclement weather. All patrons **MUST VACATE** the premises **if there is any thunder or lightning** as determined by the pool attendant.

**The pool may be closed for maintenance, hazardous health conditions or any other purpose deemed sufficient by pool attendant or pool Management Company. NOTE: THE POOL WILL BE CLOSED FOR 72 HOURS IF THERE IS AN E-COLI CONTAMINATION.**

**Tenants** – Owners who rent must supply the tenant with a copy of these rules and regulations. Owners who rent their property may **not** use the pool or facilities. **Also, Owners must notify Blue Sky Management (302) 541-0889 that their Unit/Home is a rental and tenants will be using their pool pass.**

**Guests** – **Guests must be accompanied by a Homeowner residing at Bethany Meadows and guests must be staying at that homeowner's residence.**

The following rules and regulations are for the protection, health and safety and benefit of the individuals entitled to utilize pool facilities. The rules and regulations have been established not only to assure safety and sanitary operation of the pool and facilities, but also to provide a recreation area for your enjoyment. **Owners are required to acquaint their children, guests and tenants with these rules and to caution them to observe all rules and obey instructions from pool management or pool attendant. Abuse and/or failure to comply with these rules shall be considered sufficient cause to prevent and/or restrict the usage of pool and facilities.**

**NOTE: VANDALISM TO ANY PORTION OF THE POOL FACILITIES INCLUDING RESTROOMS AND OFFICE WILL NOT BE TOLERATED. VIOLATORS WILL BE PROSECUTED AND BANNED FROM FURTHER USE OF THESE FACILITIES. ALSO, ANYONE CAUGHT USING THE POOL FACILITIES WHILE POOL IS CLOSED WILL BE CHARGED WITH CRIMINAL TRESPASSING AND PROSECUTED TO THE EXTENT THE LAW ALLOWS.**

# POOL RULES ON REVERSE SIDE

## Member Obligations, Conduct and General Rules

1. Babies and small children are **NOT ALLOWED IN** the swimming pool unless accompanied by an adult. **All children in diapers must adhere to the Delaware State Ordinance and wear rubber pants while in the pool (SWIMMIES) Del. Law 26.704**
2. Persons with visible sores or infections will **NOT** be allowed in the swimming pool. **Del. Law 26.705**
3. **A SHOWER IS REQUIRED of every person before entering the pool.** Delaware Law for pools 26.312 (Sand shortens the life of the pool and equipment.)
4. **All children under 16 years of age MUST BE accompanied and supervised by a parent or responsible adult (18 years of age or older)** a guardian is an adult designated by a parent who is responsible for the children and their behavior. **Delaware Law for Pools 26.708**
5. All children above the age of 16 **may be asked** to pass a swimming test to the satisfaction of pool management or pool attendant to enter the pool.
6. **NO RUNNING, WRESTLING, HORSE PLAYING OR FOUL LANGUAGE** within the pool area. **ABSOLUTELY NO DIVING INTO THE POOL.** Doing so will result in **loss of pool privileges.**
7. Small Floatation devices are permitted at the discretion of pool management and/or pool attendant. **NO BOOGIE BOARDS, NO LARGE RAFTS, NO BALL PLAYING** is allowed in or around the pool deck.
8. **NO PETS ALLOWED** in the pool area or within the surrounding area of the pool. **Del. Law 26.703**
9. **NO FOOD, NO GLASS CONTAINERS, NO SMOKING, OR ALCOHOLIC BEVERAGES ARE ALLOWED** in the pool area.
10. All members and guests **MUST** wear proper clothing for bathing and sunning at all times. **NO CUT-OFF JEANS, SHORTS OR THONG BATHING SUITS** are allowed in the swimming pool.
11. Chairs, lounges and tables **CANNOT** be reserved for members or guests. The use of chairs and tables are on a first-come basis. **TABLES MUST NOT BE MOVED FROM THEIR LOCATION.** If you put up an umbrella, please put it back down before you leave.
12. **All persons using any of the pool facilities do so at their own risk.** The Association will **NOT** be responsible for any accidents or injuries in connection with such use.
13. The Association **will NOT** be held responsible for loss or damage to personal property.
14. All suggestions or concerns **MUST** be in writing and submitted to pool management.
15. **SPITTING, SPOUTING of WATER, BLOWING OF NOSE OR DISCHARGING BODILY FLUIDS IN THE POOL IS STRICTLY PROHIBITED.**
16. **ANY BEHAVIOR, WHICH THREATENS THE SAFETY OF POOL MANAGEMENT, POOL ATTENDANT, OR ANY OTHER INDIVIDUAL AT THE POOL AREA, WILL NOT BE TOLERATED. IMMEDIATE POLICE ASSISTANCE WILL BE USED.**

**17. NO SCOOTERS, ROLLER BLADES, SKATES, BIKES, or SKATEBOARDS ARE ALLOWED IN POOL AREA.**

18. Executive Council Members, Management or pool attendant has the authority to enforce these rules. **ANYONE disregarding these rules will be asked to leave.** These rules and regulations may be revised at any time by pool management. Notice of any changes will be posted on the pool Bulletin Board.

**19. NOTE: THE POOL WILL BE CLOSED FOR 72 HOURS WHEN THERE IS AN E-COLI CONTAMINATION.**
